Background

1. Under the Policing and Crime Act 2017, the London Fire and Emergency Planning Authority was abolished on 31 March 2018 and the Greater London Authority Act 1972 amended to establish the London Fire Commissioner (the Commissioner) as a corporation sole and new functional body from 1 April 2018.
2. As part of their establishment the Commissioner adopted a corporate seal, to be used as the Commissioner's corporate signature on documents which are prepared as deeds (LFC-0002-D).

- 3.. With Her Majesty having granted the licence to transfer LFEPAs Arms to the Commissioner, it is recommended that the Commissioner's corporate seal should now be in the following form:
