Bailey, Bush and Butterfield House SE18 4GA: I understand than an audit has been carried out early this year so I would kind request a copy with your recommendations.

Bailey House

The most recent fire safety audit of Bailey House took place on 19 February 2021. The result of this audit confirmed no significant failure to comply with the Regulatory Reform (Fire Safety) Order 2005 (RRO) were found and as a result the premises was deemed broadly compliant. This means that no enforcement action (informal or formal) was required as a result and no notices were issued.

Bush House

The most recent fire safety audit of Bailey House took place on 19 February 2021. The result of this audit confirmed no significant failure to comply with the Regulatory Reform (Fire Safety) Order 2005 (RRO) were found and as a result the premises was deemed broadly compliant. This means that no enforcement action (informal or formal) was required as a result and no notices were issued.

Butterfield House

The most recent fire safety audit of Bailey House took place on 19 February 2021. The result of this audit confirmed no significant failure to comply with the Regulatory Reform (Fire Safety) Order 2005 (RRO) were found and as a result the premises was deemed broadly compliant. This means that no enforcement action (informal or formal) was required as a result and no notices were issued.

We do also hold the audit report forms completed during these Fire Safety Audits. Whilst the LFB freely provide the outcome of the Fire Safety Audits and notices issued, other materials such as the fire safety audit report documents themselves, are exempt from access under the freedom of information act. We consider these to be exempt under <u>Section 31 of the FOIA</u> ("law enforcement" – Section 31(1)(g) combined with 31(2) (a) and 31(2) (c)).

We are of the view that the correct balance between the public interest in building safety and our ongoing regulatory involvement lies in making information about enforcement action available (formal or informal) to those that request it, but in withholding the supporting information and evidence gathered during regulation activities. In this case, where there is no fire safety concern that merits either formal or informal action, then this information should be protected from publication to preserve the safe space for good regulation principles and that any withheld information could be used at a later date as part of formal enforcement action or prosecution where the materials go to demonstrate the behaviour, actions or omissions of the responsible person.

I would also like to obtain a copy of the Local fire fighter plan

Information obtained through LFB fire station crew familiarisation visits to premises is recorded on the LFB Operational Risk Database (ORD). The ORD is a 'live' database, which is updated with new information as it is identified. I have attached the most recent ORD reports for Bailey, Bush and Butterfield House. Please note, these will include any information recorded in earlier visits.

Personal data has been removed from the attached documents under section <u>40 of the FOIA – Personal</u> Information.

On 07/10/2021 you also asked two further questions in relation to the ORD reports supplied to the Master Gunners' Residents Association under FOIA5600.1 issued on 19 April 2021 (a copy of this response is attached to this response).

Are you working based on the information provided by the management company or drawings? When are you planning to visit again the building?

In response, detailed information about how information gathered and recorded during crew familiarisation visits can be found online in LFB policy no. 800 (management of operational risk information). The policy can be accessed via the following <u>link</u> (page 9 onwards). You will see that lots of different information is considered when completing the Operational Risk Database (ORD).

Pages 15 - 18 of this document (pages 7 to 10 of actual policy) includes details of information recorded on the Operational Risk Database (ORD) during familiarisation visits by local station crews (referred to as 7(2)d visits);

Appendix 4 on page 27 of this document (page 19 of actual policy) includes additional details on completing the ORD record;

Appendix 3 - Electronic Premises Information Plates (ePIPs) on page 26 of this document (page 18 of actual policy) includes detailed information about recording the layout of buildings.

The frequency of station visits to particular buildings is based on a Premises Risk Assessment (PRA). This determines whether the site requires a scheduled station visit, the frequency of the visits and the level of information that should be recorded and level of information on the tactical plan. Details about PRA are also included in policy no. 800 (management of operational risk information).

I **determine** Assistant Commissioner (Community Safety) on behalf of the London Fire & Emergency Planning Authority (the Authority) hereby give you notice that the Authority is of the opinion that you, as a person being under an obligation to do so, have failed to comply with the duties placed upon you by the Regulatory Reform (Fire Safety) Order 2005 (the Order) in respect of the above named premises, the relevant persons who may be on the premises or who may be affected by a fire on the premises.

The matters which, in the opinion of the Authority, constitute the failure(s) to comply with the Order are specified in the Schedule attached to this Notice.

The relevant extracts of the legislation are attached.

The Authority is further of the opinion that the steps identified in the Schedule to this notice must be taken to remedy the specified failure(s) to comply with the Regulatory Reform (Fire Safety) Order 2005.

Unless the steps identified in the Schedule attached to this notice have been complied with, or such other steps are taken to remedy the failures in consultation with the Authority, you will be deemed not to have complied with this notice.

There may be suitable alternative safety measures, to those detailed in this notice, that would meet the requirements of the regulations. If you wish to propose or discuss any alternative measures you should contact the person named below, before you take any action, to ensure that your proposed measures will be deemed satisfactory by the Authority.

The steps must be taken by 12th March 2007 (or such extension if granted by the Authority).

If you fail to comply with the requirements of this Notice, you may have committed an offence. The Authority may consider a prosecution against you. If you are found guilty, you will be liable to a fine or imprisonment (or both).

You have the right to appeal against this notice, by way of complaint for an order, to the Clerk to the Court of the Magistrates' Court acting for the petty sessions area in which your premises is located. If you wish to bring an appeal, you must do so within 21 days of the date this notice is served on you. The Magistrates' Court Act 1980 will apply to the proceedings. The bringing of an appeal will suspend the operation of this enforcement notice. An appeal against an enforcement notice served under Article 30 of the Regulatory Reform (Fire Safety) Order 2005, may be brought on any grounds. These may include that you are aggrieved:

- a) by anything mentioned in the notice with respect to the premises concerned, or the relevant persons as defined by the Order, being a step which must be taken in order to comply with the Fire Safety Order; or
